## Water manager report - Doug Hale

- 1. Not a lot going on for testing except monthly bacteria test
- 2. Metal and mineral test coming up
- 3. Efficiency and use report 38% of water pumped unaccounted for for the year (ie, water loss). Last 3 year average was 58%
- 4. Chlorine readings have been below min requirement Doug will work with James on getting this up to a normal level. Dottie has finished her testing tenure.
